Once the app is on and the driver is waiting for a request, a smaller layer of coverage generally applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It can be the difference between a modest policy and a substantial one, and the app data that establishes it belongs to the rideshare company.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each one can reach different policies.
