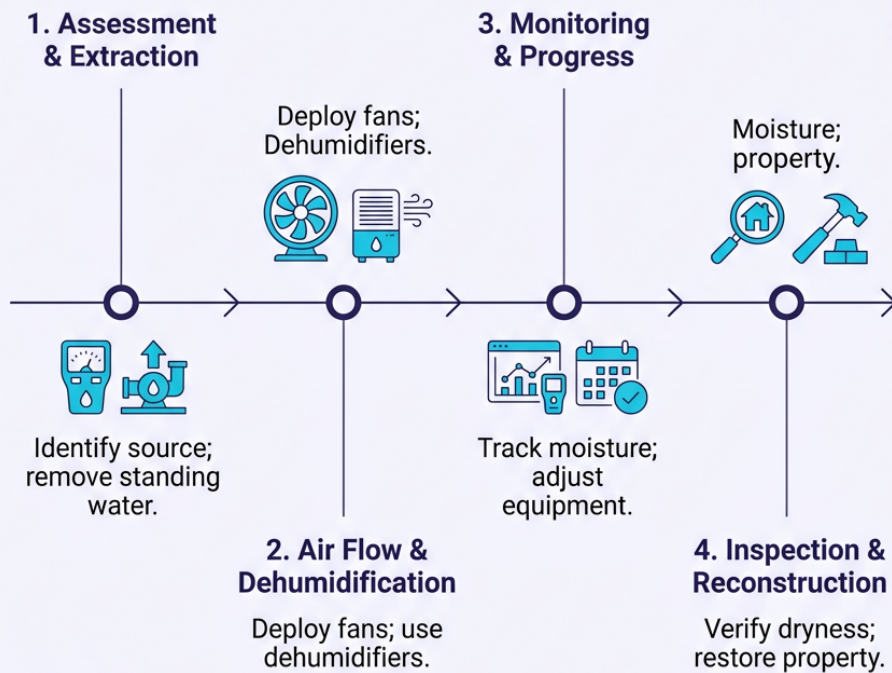
What does a secondary-damage prevention checkpoint accomplish in the first critical hours?

What does escalation workflow prevention mean when drying equipment fails to meet your home's actual moisture load?

Many water damage repairs stall partway through because the initial equipment deployed was undersized for the actual moisture load or the drying environment changed. Our escalation workflow is the decision gate that prevents this stall. If our daily moisture readings show that current equipment is not moving the needle, we escalate: we add dehumidifiers, open wall cavities for direct air circulation, or deploy desiccant drying to strip moisture from the air itself. This is not a failure—it is a prevention checkpoint working. Without it, homeowners often believe drying is "done" when surfaces feel dry but cavity moisture remains at dangerous levels. That trapped moisture then generates mold and rot over weeks, turning a \$5,000 restoration into a \$25,000 structural repair.
