

How the Anion Gap Evaluates

The **anion gap** is a useful way to review **serum chemistries** and look for clues about **acid-base balance**. It examines the major measured **electrolytes** in a blood sample to estimate whether there are notable **unmeasured anions** present. 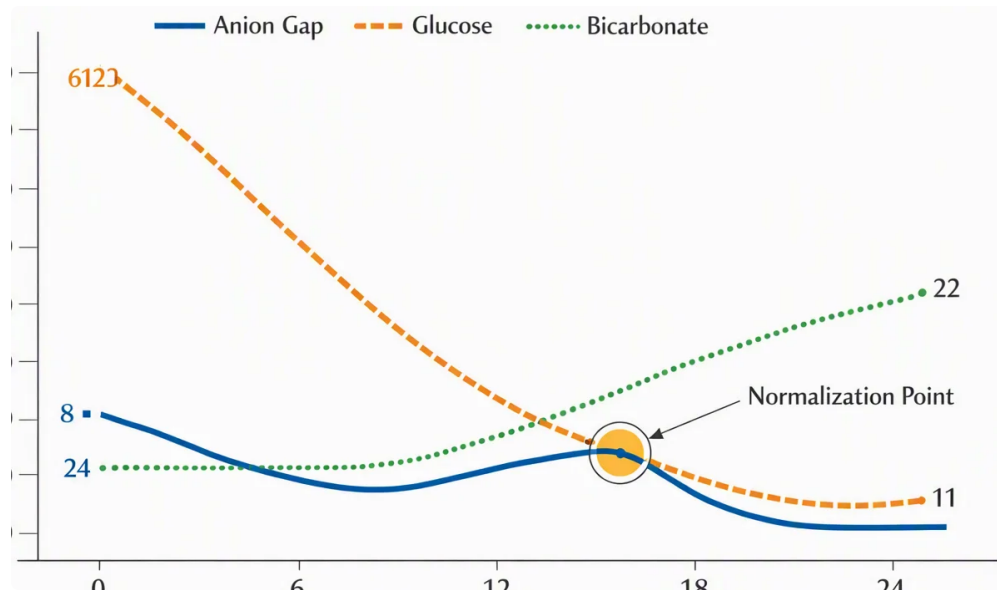
