

Getting hit by an 18-wheeler is not a bigger fender bender. A loaded tractor trailer can weigh many times what your car weighs, and the injuries are usually far worse.

The difference starts in the first hours. The trucking company often sends its own people to the scene the same day, before you are out of the hospital. They begin building the company's side of the case right away.

Much of it can be overwritten or discarded on a normal schedule, so a preservation demand is typically sent right away.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
