

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, usually when the bills arrive or an insurer calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious suffering before death.

Georgia law sets an [atlanta personal injury attorney](#) order for who may bring that first claim. A surviving spouse generally comes first, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some of them are shorter than the general rule. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, particularly where a commercial vehicle or a business is involved.
