

If a dog bit you in Atlanta, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. Georgia does not work that way. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local **car wreck lawyer Atlanta** leash ordinance.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

Records disappear quickly here. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
