

What Is the Anion Gap and How Is It Computed?

The **anion gap** is a derived value that helps clinicians assess **acid-base balance** and recognize an underlying **metabolic acidosis**. It represents the difference between the major measured cations and anions in the blood. In practical terms, it is obtained from the routine **electrolyte panel** using **sodium**, **chloride**, and **bicarbonate**.

The classic **anion gap formula** is:

$$\text{anion gap} = \text{sodium} - (\text{chloride} + \text{bicarbonate})$$

Because this is a **calculated value**, it is affected by the accuracy of the underlying lab numbers. A unexpectedly high result suggests that unmeasured anions are present in the bloodstream. 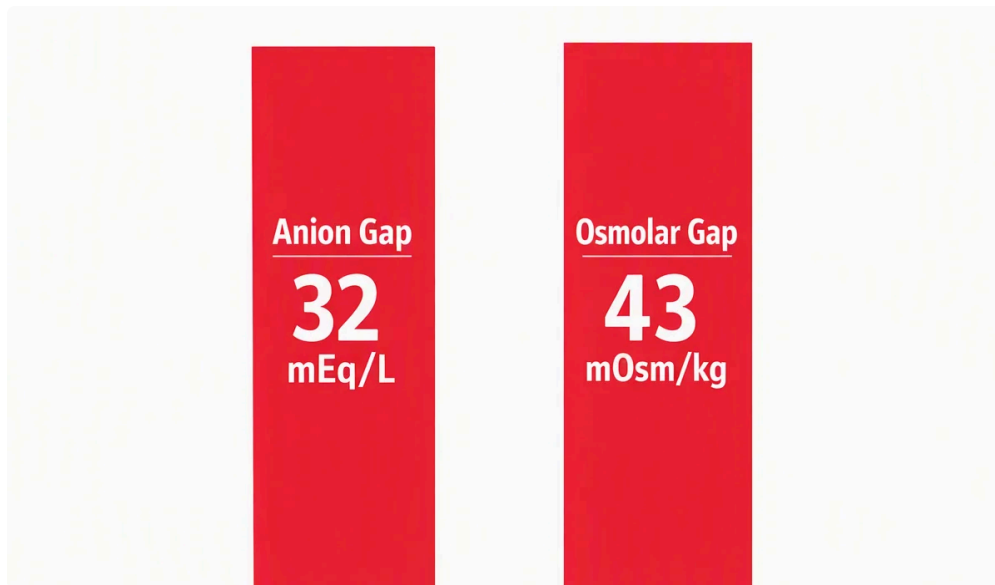
