

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, often when the bills arrive or an adjuster calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally exist. Who may bring the first claim follows an order set by statute. It generally begins with a **local car accident lawyer** surviving spouse, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some of them are shorter than **truck accident lawyer** the general rule. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also thins out, especially when a company vehicle or a business is involved.
