

When someone is shocked or burned on a job site in Georgia, the answer is rarely a single company.

That third party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.
