

If you have been hurt on someone else's property around Atlanta, there is more to it than the hazard itself. Showing the spill was there is only half of it.

Under Georgia law you generally have to show that the business knew or should have known, **car wreck settlement lawyer** caused it themselves, or would have discovered it by inspecting the way a careful owner should.

Which is why the opening weeks decide these cases. Surveillance video is often overwritten within days, and once [truck accident lawyer](#) it is gone there is no way to show how long the hazard sat there.
