

A rideshare wreck raises a question a normal car crash does not: which insurance policy actually applies. The answer turns on what the app was doing when the crash happened.

When the app is off, the driver is just a driver, and their personal policy applies. When the app is on and they are waiting for a ride request, a smaller layer of coverage generally applies. Once they have accepted a ride or have a passenger in the car, a much larger commercial policy typically comes into play.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
