

What is the Anion Gap?

The **anion gap** is a computed figure used to assess **acid-base balance** by comparing major measured ions in a **serum chemistry** or **electrolyte panel**. An **Anion Gap Calculator** helps doctors and learners easily determine whether there is an unexpected amount of hidden acids in the blood. Delta delta analysis is used to determine whether a patient with a **high anion gap** also has an additional acid-base process. Step 5: Compare it with bicarbonate loss. If normal bicarbonate is 24, the bicarbonate drop is $24 - 14 = 10$.

Step 6: Determine the delta ratio. Delta ratio = $14 / 10 = 1.4$.

Interpretation: A ratio around this range often fits a straightforward high-gap metabolic acidosis, without a strong signal for a second major process. However, if the bicarbonate had been much lower than expected, that would suggest an added **normal anion gap metabolic acidosis**. If the bicarbonate had stayed higher than expected, a concurrent alkalosis would be considered.

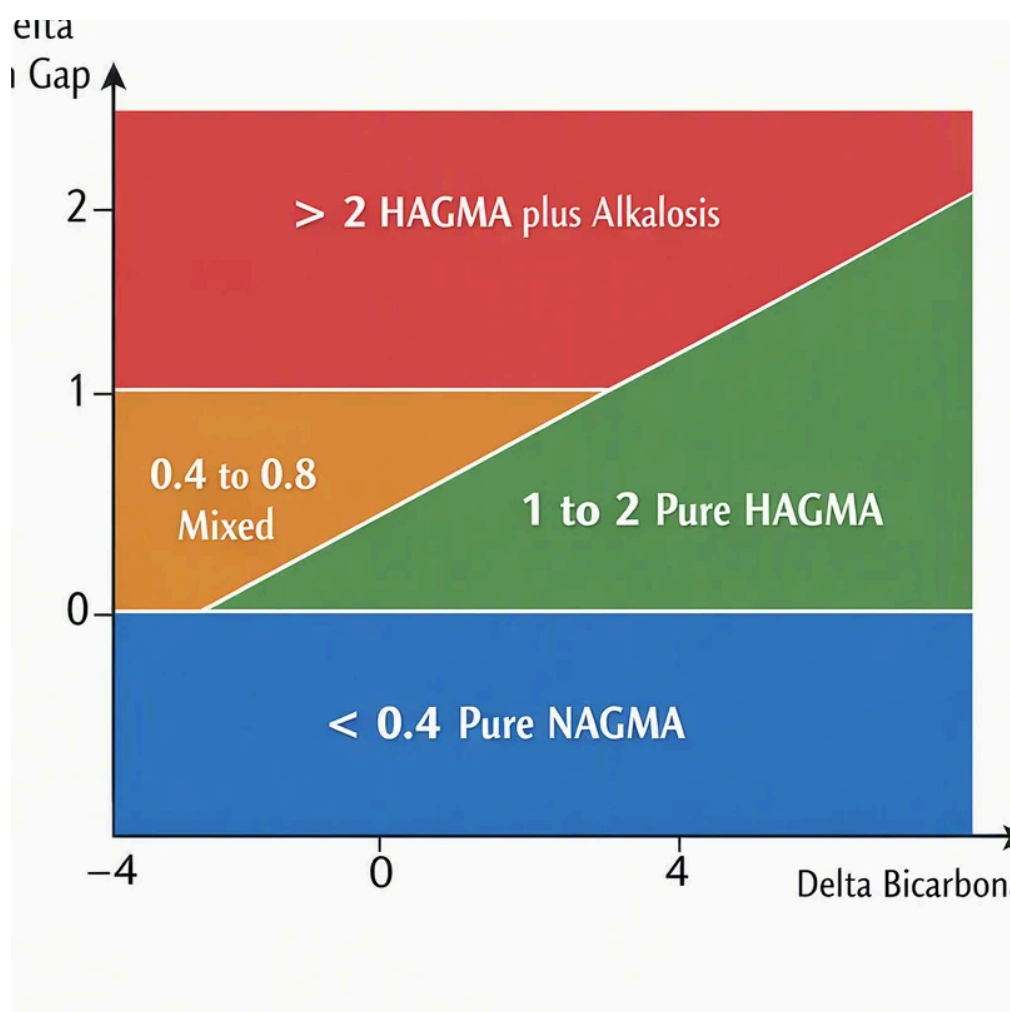
