

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one eventually, often when the bills arrive or an adjuster calls.

Georgia treats a death case differently than people tend to assume. Two separate claims generally **More help** exist. Georgia law sets an order for who may bring that first claim. It generally begins with a surviving spouse, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also disappears, especially when a company vehicle or a business is involved.
