

When a rider is hurt and were hit in Atlanta, there is a prior you have to overcome.

There is a built in bias in motorcycle claims: that the rider was speeding, was lane splitting or weaving, or accepted a risk nobody else would.

Sometimes it fits. Frequently the driver simply did not see the motorcycle and turned across it.

Reconstruction matters more here than testimony, because narrative starts at a disadvantage. The geometry of the turn do the arguing.
