

What the Anion Gap Calculator Can Do

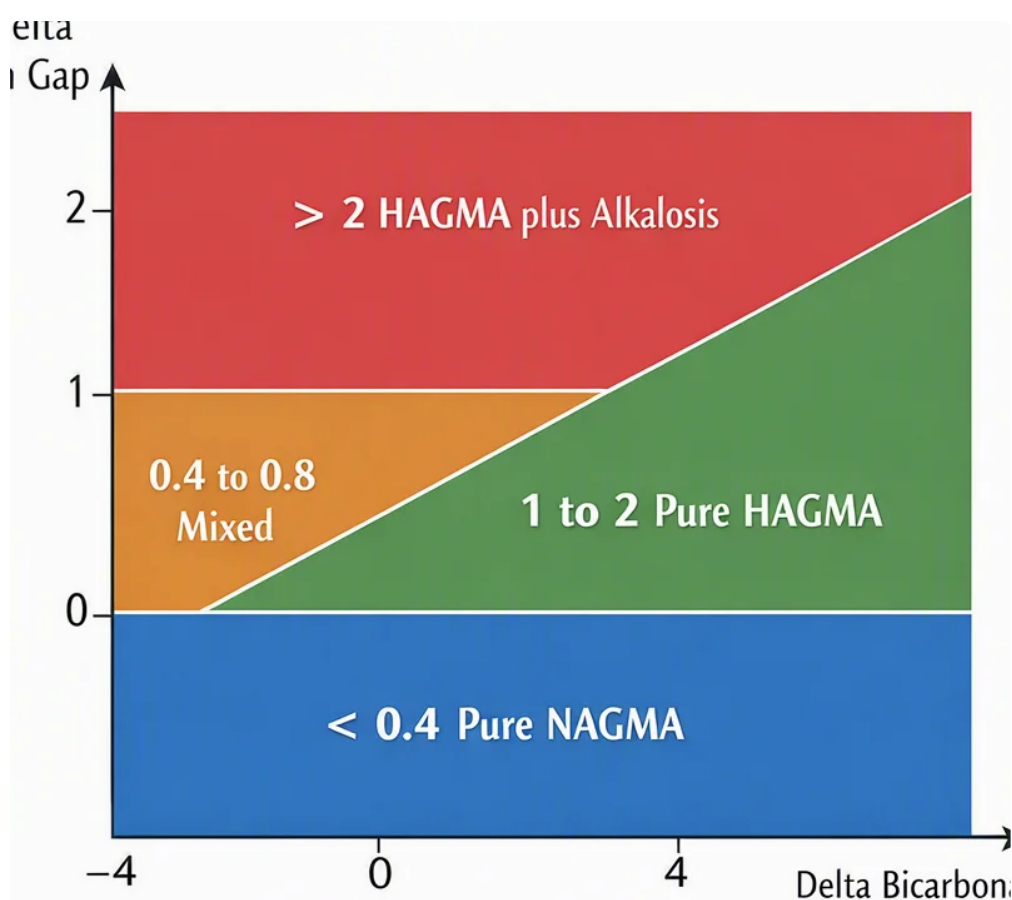
